Spring Festival	From Jan.25 to Jan.31	7	Jan.25 (Sunday), Jan.26 (Monday) , Jan.27 (Thursday) are legal holidays;Jan.31 (Saturday) are as usual; Jan.25 (Sunday) moves to Jan.28 (Wednesday) , Jan.24 (Saturday) , Feb.1 (Sunday) move to Jan.29 (Thursday) , Jan.30 (Friday) . Jan.24 (Saturday), Feb.1 (Sunday) is time to work.
Tomb-sweeping Day	From Apr. 4 to Apr. 6	3	Apr.4 (Saturday) is legal holiday, Apr.5 (Sunday) are as usual. Apr.4 (Saturday) moves to Apr.6 (Monday).
Labor Day	From May 1 to May 3	3	May 1 (Friday) is legal holiday, May 2 (Saturday), May 3 (Sunday) are as usual.
Dragon boat Festival	From May 28 to May 30	3	May 28 (Thursday) is legal holiday, May 30 (Saturday) are as usual; May 31 (Sunday) moves to May 29 (Friday) ; May 31 (Sunday) is time to work.
Mid-autumn Festival & National Day	From Oct. 1 to Oct. 8	8	Oct.1 (Thursday) , Oct.2 (Friday) , Oct.3 (Saturday) are legal holidays , Oct.4 (Sunday) are as usual , Oct.3 (Saturday) moves to Oct.5 (Monday) , Oct.6 (Tuesday) , Sep.27 (Sunday), Oct.10 (Saturday) move to Oct.7 (Wednesday), Oct.8 (Thursday) .Sep.27 (Sunday), Oct.10 (Saturday) is time to work.
